# TITLE: TENDER FOR THE SUPPLY AND INSTALLATION OF A FIREWALL

#### · 1. About Us

2. Objective of the Assignment

To procure, install, configure, and commission a next-generation firewall solution that meets international security standards and regulatory requirements, thereby strengthening the security posture of SGM's ICT infrastructure.

## 3. Scope of Work

The selected vendor shall be responsible for:

- Supplying a Next-Generation Firewall (NGFW) device with the following minimum features:
  - o Intrusion Detection and Prevention System (IDPS)
  - o Application control and filtering
  - o Advanced threat protection (malware, ransomware, etc.)
  - VPN support (IPSec and SSL VPN)
  - Web filtering and content control
  - o High availability (HA) capabilities
  - Logging and reporting tools
- Conducting a site assessment to determine optimal installation and configuration.
- Installing and configuring the firewall at SGM's head office.
- Integrating the firewall into SGM's existing network infrastructure.
- Creating access control policies, security zones, and rules based on SGM's security needs.
- Testing the firewall installation and ensuring seamless operation.
- Training IT staff on the operation, monitoring, and basic troubleshooting of the firewall.
- Providing user manuals, system documentation, and warranty details.
- Providing post-installation support and maintenance for a minimum period of one year.

#### 4. Deliverables

The consultant/firm is expected to deliver:

- 1. Fully installed and operational firewall system
- 2. Site assessment and installation report
- 3. Security configuration documentation
- 4. Training report and attendance
- 5. Warranty and support agreement
- 6. Final project completion report
